# MESSAGE FROM THE CAO





**Municipal Taxes (55%)** are the net municipal portion of all property taxes levied or collected.


**Sales and User Fees (31%)** are the funds raised for utilities and other services charged to the user.

**Franchise Fees and Leases (8%)** are funds raised through lease or license of municipal property and the fees charges to Fortis Alberta for its electric distribution system and ATCO GAS for its gas distribution system within the Town of Gibbons.

**Other (1%)** includes revenues which are not included in the above categories. This includes fines, interest, and some planning-related revenues.

**Government Grants (3%)** are funds provided by senior levels of government for operations within the Town.






## **2020 CAPITAL EXPENDITURE BY AREA**

2020 was a busy year in spite of COVID 19. The Town moved froward with all of its budgeted capital projects. Work was started in Memorial Park, 2 new-to-us Firetrucks were purchased so to ensure coverage for the Town when our current truck reaches the end of its life. The paving surrounding the arena and curling rink was completed. Heartland Meadows underground servicing projects met with satisfaction so therefore holdbacks were released. Pickleball courts were installed, the curling rink upstairs saw a face lift and new vehicles and equipment were purchased.






Municipal Sustainability Initiative (MSI) Capital funds comprised of 1/3 of the revenue for our capital projects, followed by revenue from utility reserves. Next on the Town's capital plan was usage of the Federal Gas Tax Fund. The completion of the Heartland Meadows project used up the remainder of the debenture that was taken out in 2019.

The 2020 capital plan totaled \$2,536,715.61.



### **PENALTIES**

A 10% penalty is applied on July 1 on any current outstanding amounts.

Another 16% penalty is applied on January 1 on all outstanding amounts.

# **DEPARTMENT UPDATES**

### **CORPORATE SERVICES**

In 2020 the Corporate Services department conducted business mostly as usual - COVID 19 did have an impact and the Town Office was closed to the public for a period of time but staff continued to work from the office. When things were relaxed, we welcomed residents back with a few minor changes. Two long term employees left us for retirement, so our department saw shifting of positions with the existing staff. A new administrative staff member was welcomed in September and was a positive addition to our team. A new telephone system was implemented in 2020 which did create a few hiccups but has been an improvement to our ability to provide professional service to our community.

In terms of municipal taxes, the Town was able to maintain the net tax collected at slightly below 2019 levels while maintaining levels of services. On the utility front, water and wastewater rates were increased very slightly as part of the Town's utility sustainability plan—the intent being to ensure the utilities are self-sustaining and not subsidized by taxes.

Despite the difficulties encountered from the pandemic, 2020 was a positive year and the Corporate Services Department will continue to work hard and be responsive to ratepayer needs. Please feel free to reach out to the Town office—we're happy to help.

### **PUBLIC WORKS OPERATIONS**

WATER OPERATIONS

- We had a 300mm PVC watermain installed to create a loop along 44 Avenue between 47 Street and Poplar Drive with all associated valves, a hydrant and lead relocation.
- A portion of 150mm AC watermain and valve were abandoned with the removal of a tee and replaced with a pipe in a rear lane.
- Replaced a 350mm valve at our Pump House
- Removed and replaced a storm manhole, catch basins and leads at the intersection of 44 Avenue and 47 Street.
- Resurfaced all area once work was completed.

SOUTH OUTFALL LINE

**DRAINAGE** 

- After years of seeking approval, we completed the South Outfall to ensure we have an environmentally friendly, efficient and safe storm water release into Sturgeon River.
- Started to improve the water drainage from Landing Trails area to our storm outfall by clearing existing ditches and creating a new one to increase water flow and prevent flooding.

# ROADS, SIDEWALKS & CURBS

- Completed various sidewalks, curbs and gutters around Town this is an ongoing yearly project at \$100k per year. We have started to install concrete swales in the old core of Town as it is all surface drainage. The first 3 were installed in 2020, with 3 to be installed every year thereafter until completed.
- Finished a concrete sidewalk from 50th Avenue to the skateboard park.
- Paved area near the front of the Arena to the entrance of the outdoor arena.
- Installed half of the Zamboni room floor to improve drainage.
- Installed a Gazebo concrete pad by the youth centre.

# VEHICLE PURCHASES

- 2020 Freightliner dump truck to replace the 1991 International dump truck.
- 2016 Ford 550 to replace a 2001 GMC 3500

### **COMMUNITY SERVICES**

While navigating the challenges that COVID-19 brought to the world in 2020 the Gibbons Community Services Department pushed forward to safely provide Gibbons and area residents meaningful supports and activities to maintain and enrich quality of life during these unprecedented times.

- Several facilities received fantastic upgrades and new amenities were added to the community as well.

### **Recreation:**

- Initiated the Recreation and Parks Master Plan.
- Summer programs continued (in-person and virtual).
- Youth Centre programming continued (in-person and virtual).
- Recreation and fitness programming continued (in-person and virtual).
- Position of Recreation and Youth Coordinator was filled.

Recreation services continued to be offered throughout the year. Some of these services might have looked a little different from other years but our staff worked hard to keep everyone safe, healthy, and connected.

### **Social Services:**

- Government of Alberta contract ended for prevention and early intervention services, removing some programs out of the Gibbons Family Resource Centre. Family Resource Networks were implemented regionally, Gibbons' FRN is based out of Fort Saskatchewan.
- Out of School Care merged programs out of Bon Accord and Gibbons, moving to their new location in the Cultural Centre as "The Landing Pad."
- Social programs such as Home Alone, Babysitting, and Income Tax Programs continued.
- The Gibbons Family Resource Centre remained open to all in need, and to help maintain services of partner organizations and programs such as the Bon Accord Gibbons Food Bank, Meals on Wheels, and the Community Clothing Closet.

### GIBBONS VOLUNTEER FIRE DEPARTMENT


- We currently have 23 active members

# Significant development projects of note that were completed or received approval:

- We held 2 local business breakfasts in 2020. We are planning to hold one mid to late September. The Town kept the businesses updated with information on government grants and restriction changes during COVID.
- We continue to work with MIX 107.9 updating our advertisements every 2 3 months. Although we were not able to have broadcast people in our office we did participate in the 10 Town Tour/Heartland Tour in 2020 and 2021 with interviews with the Mayor and several staff members.
- We continue to work with our regional partners to provide education courses for local and regional businesses. A Regional Business Breakfast was held in 2019 and one is being planned for this fall.
- This year the Town started sending out information packages to new residents. These packages include information from the Town as well as information and swag from local sponsoring businesses.

Council holds two regular meetings each month (one in July and one in August) on the second and fourth Wednesday of each month.
